Energy taxation Directive & links to other construction dossiers

The publication of a European Commission (EC) proposal to revise the 2003 EU Energy Tax Directive is expected in the next few weeks as part of a package of measures on environmental taxation. Back in 2003, the EU adopted Directive 2003/96/EC which restructured the framework for the taxation of energy products and electricity and which then came into force in 2004. The interesting part is that the Directive

in 2004. The interesting part is that the Directive allows Member States (MS) to offer companies tax incentives in return for specific undertakings to reduce emissions. Now the proposal drawn up by the EC Taxation and Customs Union Directory General is expected to include "explicit" environmental elements.

This awaited EC document is linked to the EU economic recovery plan - COM(2008) 800 - published last December and in which the EC clearly states that lower tax rates for "green products" and services would be proposed to help improve the energy efficiency of buildings and boost sustainable consumption. The recast of the Energy Performance of Buildings Directive (EPBD) -COM(2008)780 - is currently debated in the European Parliament (EP) and this foreseen EC financial plan for the construction industry may impact on the revision

of the EPBD and the objectives that will be set in the legislative document. The EP Socialist rapporteur, Mrs Silvia-Adriana Țicău (Romania) is currently calling for changes in the European Regional Development Fund (EBRD) investments in construction.

As explained in previous editions of our Newsletter, one of the aims of the recast



would be that all new public buildings should be low or zero emissions by 2015 and Member States (MS) want their public sectors to lead in this field. The sustainable construction sector is presented by some political actors as the way-out of the deepening financial crisis. However, a number of MS do not share the rapporteurs's enthusiasm amongst other things, they are concerned with the drive towards minimum national energy efficiency standards for all buildings undergoing major renovation and a mandatory EU-wide formula to calculate cost-optimal minimum energy efficiency standards from 2017. The European Parliament (EP) and Council are aiming to reach a agreement by the end of the year under Swedish Presidency of the EU and a 1st Reading in the EP is scheduled for April.

As the June European elections draw near, our Members of the European Parlia-

ment (MEPs) are already on the campaign trail and so visibility is key especially on environmental issues. Another file being rushed through the EP, is the EC Eco-design Directive. In the Council, the other EU decision-making body, the views are diverging with the UK, Denmark, Finland, Ireland, The Netherlands and Sweden saying that the

EC proposal to update the existing label would confuse consumers, whilst Germany, Spain, Italy, Poland and other eastern European MS supporting the EC proposal. A new energy label and efficiency standards for "energy related products" are expected to be adopted by the end of April, a busy month in perspective!

"Trends in High Performance Buildings & the role of Ventilation" Berlin, I-2 October 2009


